Pag-IBIG Fund opens Muntinlupa Branch

As part of its ongoing efforts to bring Pag-IBIG services closer to its members, the Pag-IBIG Fund recently opened its Muntinlupa Branch office located at the 3rd floor Sycamore ARCS1 Building, Buencamino St., Alabang-Zapote Road, Muntinlupa City. Headed by Mr. Romeo H. Ocampo, the branch covers nine out of the 47 barangays in Muntinlupa under the Makati III branch office. The nine barangays are: Alabang, Ayala Alabang, Bayanan, Buli, Cupang, Poblacion, Putatan, Sucat, and Tunasan. Pag-IBIG President Atty. Darlene Marie B. Berberabe led the inaugural ceremony.

“Pag-IBIG’s mantra is Bigger, Better, Faster. The directive of Pag-IBIG Board Chairman, Vice President Jejomar C. Binay, is to make our services accessible and closer to our hardworking members. Thus, we are working on expanding our presence in more cities and municipalities all over the Philippines,” said Atty. Berberabe.

The Muntinlupa Branch accepts payments of membership savings from both employers and individual payors, as well as payments under the Modified Pag-IBIG 2 Program. It also accepts Housing Loan amortization payments, provided that the borrower presents the Official Receipt of his last payment or the Payment Order Form. Members can also file their membership applications, and applications for Housing, Multi-Purpose, and Calamity Loans at the branch.

The Pag-IBIG Muntinlupa Branch is the first branch to open in 2014. It services more than 2,300 employers with a total membership of 137,261. Currently, Pag-IBIG has 63 branches nationwide and 19 posts abroad, with more to be opened this year.
